There was a piece in the *Daily Telegraph* (4 May) making the striking claim that 'Trump's hundred days have been a triumph. The swamp is being drained'. The Starmer mystery

The always interesting Craig Murray wrote this recently:

It remains my belief that Starmer has always been a deep-state operative and that he is deliberately driving the Labour Party to its own destruction. Among the strongest evidence for this, in my view, is the fact that all of the documentation on his involvement in the Assange case, the Savile case, the Janner case, and other high-level paedophile cases while he was Director of Public Prosecutions was allegedly destroyed by the state while the Conservatives were in office and Starmer in opposition. The Deep State was protecting him and preparing his way to power.

When I clicked on 'Assange case' and 'Savile case' in the paragraph above I got nothing, '404' in both cases. The closest you can get about Assange/Starmer on *Declassified* is a story about the Crown Prosecution Service (CPS) destroying files relating to Starmer's trips to Washington to discuss Assange while he was Director of Public Prosecutions.² The CPS claim the files were destroyed because they were of a routine nature. About which explanation *Declassified* is suitably sceptical. However, there are many reasons why such files might have been destroyed which are *not* connected to the Deep State 'protecting' Starmer. We might start with the Americans' desire not see discussions of the Assange case made public; or the British state's desire that we not see how subservient it is to its American equivalents.

On the Savile case, Murray wrote about it and Starmer's links to it, at some length in 'How the Establishment Functions'³ in 2022. He wrote this:

It is also very interesting how unanimously the Establishment has decided to protect Keir Starmer. They faced a real danger for a few years with one of England's two main parties under the control of genuinely radical figures. Having managed to get the big-money friendly Sir Keir Starmer into place and neutralize any possible threat to their wealth, the ferocity of the Establishment's defense of Starmer is fascinating.

But again, there all kinds of possible reasons why the British state didn't want public examination of its role in the Savile non-prosecution which have nothing

to do with protecting Keir Starmer. Murray continued:

But even if you do not accept my theory that Starmer may be destroying the Labour Party on purpose, perhaps you might accept that Starmer would prefer to see the Labour Party destroyed than see it in power as a left-wing party. The Thatcherite agenda of austerity, benefit cuts and attacks on the non-working and disabled, monetarism, militarism and jingoism, with anti-immigrant policies allied to unquestioning Zionism, is perhaps a true reflection of Starmer's core beliefs; as these align precisely with the Deep State agenda, the question of whether Starmer is a true believer or a blank cipher for the Deep State is moot.

But what are Starmer's 'core beliefs'? I have no idea and neither, apparently, does Murray. What evidence we have of the group which promoted him within the Labour Party, Labour Together, suggests that it was the Israel lobby who had the greatest investment in the man.⁴ On the other hand it may simply be that Starmer is just another politician – like Tony Blair and Gordon Brown – who simply wanted to be prime minister. Murray might be right about Starmer but, as yet, there is no evidence.

Dallas again

By virtue of having worked for the *Washington Post* and being cautious with his use of the evidence, Jefferson Morley has become the respectable face of the Kennedy assassination researchers for the major American media. I was looking at his site⁵ and noticed that among the handful of other sites he recommends is a British one, <22november1963.org.uk/>, 'an introduction to the JFK Assassination'. I searched it for Chauncey Holt ⁶ and found that it carried the conventional view of Holt: that his claim to have been one of the three 'tramps' photographed in Dallas had been falsified by the release of Dallas police files on three tramps who were arrested in Dallas after the shooting. Under a subheading 'Who Were the Three Tramps in Dealey Plaza?' we are told:

Plenty of people were mistakenly named as the three tramps before the

discovery in 1992 of their arrest records revealed that they were in fact just three ordinary tramps who were in the wrong place at the wrong time.

But this isn't true. As I have demonstrated before in these columns, the three tramps whose arrest records were released, were picked up shortly after the assassination.⁷ The 'three tramps' were photographed at least two hours later.⁸ Nonetheless, when the arrest records of the first set of tramps – who *were* tramps, or hobos in American English – were released by the Dallas police, the few researchers who had looked at Holt⁹ dismissed him as another fantasist, a designation which stuck. Holt then had the curious experience of being the only person to be involved – albeit peripherally – in the assassination plot who had come forward, and not be believed.

There are now two key entry points into the events in Dallas (as opposed to the cover-up). One is the tape recording of LBJ's assistant, Clifford Carter, talking about LBJ's hit-man, Mac Wallace, organising the assassination.¹⁰ The other is Holt's account of being tasked by the CIA to make a rifle which would fire rounds already fired from a Mannlicher-Carcano (the rifle owned by Oswald). The smooth bore rifle produced by Holt's team would have been weak and inaccurate when fired. This implies that the CIA wanted to fake an assassination attempt on JFK – presumably to be attributed to Lee Harvey Oswald, whom the Agency had encouraged to appear in public as a pro-Castro activist.

Rather than poring over official files which will tell us little of significance, researchers would be more usefully employed spending their time on Holt and Wallace. Jim DiEugenio, for example, has been through some of the 77,000 files related to the JFK assassination recently released. He has written an essay about some of the new information he has found and his disappointment that the major media don't devote more time and energy to

the subject.¹¹ But fascinating though the snippets DiEugenio found will be to some JFK researchers, they tell us nothing about the shots on Dealey Plaza.

Hybrid warfare

So-called 'Havana syndrome' (discussed below), the Russian assault on over 1000 US overseas diplomatic personnel, using sound or electromagnetic radiation (almost certainly the latter), has established that such devices work and are operational. Robert McCreight surveys this new field in 'The war inside your mind: unprotected brain battlefields and neuro-vulnerability'.¹² This paragraph is from his abstract.

Our brains are vulnerable daily within a complex electromagnetic—cyber —RF saturated environment and that vulnerability is critical to grasping our collective dilemma. Cognitive integrity is a paramount risk for our times.

That's not a great final sentence but the gist is clear enough.

There has been a lot of research and comment on Russia's so-called hybrid warfare – sabotage, disinformation, assassination, psy-ops etc. – as a quick google demonstrates. The *Daily Telegraph* ran a long piece on some recent events in Germany which seem to show the Russians using migrants for operations in Germany.¹³

*

One of the obvious difficulties produced by the on-going conflict with Russia is distinguishing between Russian psy-ops and the activities of those who are, as it were, not sufficiently anti-Russian.

One such incident, involving Richard Sakwa, was written recently up by Kit Klarenberg on *The Gray Zone*.¹⁴ Sakwa is a historian who has written a number of books about, or bearing on, the Russia-Ukraine conflict. They have been

widely praised, not least in these columns.¹⁵ Klarenberg wrote:

In a March 2022 email entitled "Russians in our Universities," British military intelligence officer and former senior NATO advisor Chris Donnelly accused Sakwa of being a Russian "fellow traveller" who'd been "gradually breaking cover," insisting the professor was "far too well-informed about Russian strategy to be called just 'a useful idiot." Another email reveals Donnelly fantasizing about publicly exposing the [sic] Sakwa for being "funded by Russian entities" – a claim the professor strenuously denies.

Donnelly has no evidence, of course – at least none he has revealed.¹⁶

In another email – and how Klarenberg got access to his emails is unexplained – Donnelly writes:

Ref our chat this morning about dubious people keeping their heads down at the moment, here's someone who has done the opposite. See the link below for Richard Sakwa's interview with the strongly Anglophobic LaRouche organisation.

Ah yes, the LaRouchies. I wonder if Sakwa knew anything about the organisation before the interview. About thirty years ago I used to get regular calls from one of LaRouche's people in Paris. We would have a pleasant chat about this or that; then I would say something which conflicted with the LaRouche position and, with an almost audible click, my caller's brain would turn off and he would hang up.

Empathy and Mr Musk

There has been a fair bit of discussion recently about the hostility of Elon Musk and some of the American Christian right to the concept of empathy - i.e. the ability to care about the pain or suffering of others.¹⁷ There has been a good

deal of research into empathy in the past decade,¹⁸ the conclusion of which might be summarised thus:

The researchers found that leftists' brains display a stronger empathetic response to others' suffering than the brains of rightists. The tempoparietal junction is a part of the brain that is important for humans' ability to "putting yourself in others' shoes", also called cognitive empathy. This brain area was more active during the empathizing task in leftists than in rightists. The researchers concluded that these results support earlier observations that political leftists respond more empathetically to others' suffering than political rightists.¹⁹

So, is empathy genetic or learned behaviour? The evidence suggests that it is part genetic but can be also be learned.²⁰ Was Elon Musk born the way he is or made that way by his non-empathic father? If the Wikipedia entry on Elon's father is remotely accurate, Elon is very much his father's son.

As is common with the very rich, Musk is not one to let something as piffling as the truth get in his way. He commented recently that he was prompted to buy Twitter (i.e. what is now X) so he could remove the censorship which he was seeing on it and 'let the marketplace of ideas win'.²¹

I asked Google 'Is X censored now?' and got this:

AI Overview

regimes. This has led to concerns that the platform is not truly upholding free speech principles.

Selective Enforcement:

There have been examples of X suspending or restricting accounts, particularly those that criticized Elon Musk or his policies, while seemingly allowing other accounts to post content that could be considered harmful or problematic.

Increased Content Moderation:

X has also implemented more stringent content moderation policies, leading to a significant increase in account suspensions and content removals.

Public vs. Private:

Kincora was a honeytrap?

David Burke is an Irish barrister who is writing about events during 'the Troubles'. His *Operation Clockwork Orange*²² was discussed in this column in *Lobster* 86²³ and John Newsinger recommends his *Kitson's Irish War* in his review of Kitson's memoir in this issue. Burke has a new book out, *The Puppet Masters: How MI6 Masterminded Ireland's Deepest State Crisis* (Cork: Mercier Press, 2024). In that there is this paragraph:

Bearing this in mind, it is not difficult to understand how he had the stomach to oversee MI6's egregious Kincora Boys' Home child abuse 'honey trap' operation in Belfast.⁸ Teenage boys were used as bait for Loyalist politicians and paramilitaries. A series of Loyalist paedophiles were ensnared by the scheme, including members of parliament.²⁴

And his source for this claim? His note 8 reads 'Private interview with MI6 operative'. Which isn't enough for such a startling claim, is it? And assuming it to be true, who could that MI6 source be? Who is still alive from those days?

Lyalin

I was talking to Peter Sanderson, whose experience in 'the British Gladio' is at the centre of the essay on that subject in *Lobster* 81.²⁵ He reminded me that the immediate cause of the revival of the British 'stay behind' network in the mid 1970s was the reports of Oleg Lyalin, a KGB officer in the UK, who defected in 1971.²⁶

LYALIN was in the process of selecting and reporting on sites to be used for the infiltration by air and sea of Soviet sabotage groups into the UK during the period of crisis preceding the outbreak of conventional war. He had submitted a comprehensive plan for the seaborne landing of a group (or groups) on the North Yorkshire coast and consideration was being given to the selection of a dropped zone for an airborne landing north of the Caledonian Canal. He was also building up a group of UK domiciled agents.

[...]

From what LYALIN has said, there can be little doubt that whilst taking account of the risks of attribution and escalation, the Department V. are making dispositions to commence sabotage operations in the UK in a period of possibly prolonged crisis, leading up to the outbreak of war. During such a period, a variety of sabotage measures would be taken,

including in their objectives the demoralisation of the civilian population and the complete disruption of the political and economic life of the country.²⁷

'The outbreak of conventional war' between the Soviet Union and the UK or NATO was vanishingly unlikely and Lyalin's activities were clearly at the far end of the 'just in case' category of research. Nonetheless, his testimony provided NATO with the pretext for a couple of major military exercises,²⁸ and provided an excuse for the British military to revive 'stay behind' groups.

'This is not a nothing-burger . . .'

... was Jefferson Morley's initial reaction to the JFK documents recently declassified.²⁹ Morley was referring to the revelation that head of CIA counterintelligence (CI), James Angleton, began collecting reports on Oswald in 1959. A week or so later Morley wrote:

`The new JFK files yield clear and convincing evidence of CIA responsibility for JFK's assassination . . . A small clique in CIA counterintelligence was responsible for JFK's assassination.' 30

Unless he has discovered something that hasn't been reported yet, the evidence does *not* support that conclusion. Or, rather, this is not the only conclusion the available evidence supports. The fact that CIA CI was watching Oswald does *not* tell us that CI did the shooting. And given what we know about the CIA, it is highly improbable that CI organised such an event. Angleton's interest in Oswald seems to have been part of his hunt for KGB penetration agents in the CIA. John Newman has argued recently that Oswald was sent to the Soviet Union in the hope that information he gave to the Soviets would turn up in the discourse of suspected 'moles' in the Agency.³¹

In *Lobster* 75 I noted the work of Paul Bleau in identifying other apparent, pro-Cuban patsies.³² Which makes obvious sense: if you are going to assassinate JFK – or, as I believe, *pretend* to assassinate JFK – and blame it on a pro-Castro activist, the operation would need fallbacks in case the first choice patsy was not in place on the day chosen. (Indeed, we do not know if Oswald was the first choice.) In a recent article Bleau analyses two groups of letters that have been found, apparently discussing a Cuban attempt to kill JFK. Bleau notes that this disinformation operation began shortly after the defeat of the CIA's Cubans at the Bay of Pigs.³³ Bleau concludes:

Find out who designed tactics for either the false flag plots, their rollout, the propaganda themes, and who got the instructions through to contacts in Havana to send the letters, who set up the FPCC tainting strategy . . . You have a strong case of who was behind the JFK assassination at the operations management level.

Or, I would argue, you have a strong case for who was behind the *phoney* JFK assassination at the operations management level.

Morley, Bleau and others who believe the CIA-dunit explanation of the event are either unaware of the late Chauncey Holt or have dismissed him. However, if we take Holt seriously, his account of preparing a rifle for the CIA which would take previously fired Mannlicher-Carcano rounds (the rifle Oswald allegedly fired at JFK's car was a Mannlicher-Carcano), is consistent only with a fake assassination attempt. For the rifle created had a smooth bore and was therefore relatively weak and inaccurate.

The disinformation campaign shown by the fake Cuban assassination letters began shortly after the failure the Bay of Pigs invasion in April 1961. This suggests that immediately after their Cuban defeat, the Agency began to prepare for a second invasion; and that the pretext for the invasion would be the obvious one: a (phoney) assassination attempt on JFK which would be blamed on Castro's Cuba.

More on Starmer

The essential Declassified UK reported that Keir Starmer, while a member of

Jeremy Corbyn's shadow cabinet, joined the Trilateral Commission.³⁴ He spoke at the November 2017 European annual meeting in London. His doing so is both an expression of political ambition on Starmer's part and, given his membership in the Corbyn shadow cabinet, a striking act of hypocrisy.

I am grateful to Colin Challen for the reference in his blog³⁵ to a piece by Andy Haldane. *Andy* Haldane? Yes, this is erstwhile Chief Economist at the Bank of England *Andrew* Haldane. He wrote in a recent piece in the *New Statesman:*

As they entered office in mid-2024 one thing was certain about Labour's plan for growth: they did not have one. There was no recipe book, and few raw ingredients for growth were in place. Apart from a shopping list wistfully titled 'securonomics', the kitchen at No.11 was bare.³⁶

Or, as the subtitle to his essay had it: 'The Chancellor's major announcements have been reheated leftovers from the Treasury's freezer'.

Since the Starmer group must have been preparing for office for at least two years, that they arrived with no economic policies is very striking and seems to answer the question, 'What does the Starmer government want to do?' The answer, apparently, is simply 'to be in office'.

The anti-semitism smear against Jeremy Corbyn

The recent detailed account of the rise of Keir Starmer³⁷ massively underplays the anti-semitism smear against Jeremy Corbyn. The Labour Friends of Israel get two passing references. The major media in this country is still unable or unwilling to present the episode honestly. And it's not because there is no evidence. There has been a major study of the events by the Glasgow Media Group which reported that Corbyn–as–anti-semite generated over *five*

thousand stories and articles in the three years after he became leader of the Labour Party.³⁸ Greg Philo of that Media group reported that the study's authors

commissioned Survation to ask 1,009 people how many Labour members faced antisemitism complaints, the average estimate — at 34 percent — was over *three hundred times* the published figures.³⁹ (Emphasis added.)

In a similar way, the major media have been unwilling to discuss the role of Raffi Berg, the BBC's Middle East editor, in manipulating the BBC's coverage of events in Gaza in favour of Israel.⁴⁰

Finally, John McEvoy at *Declassified UK* reported that the Israel lobby had given money to a quarter of British MPs – something else the major media has not felt worth reporting.⁴¹

Broken-down Blighty

Amidst the chorus of derision at President Trump's economic policies, I haven't noticed a single voice pointing out that his apparent aim of rebuilding the US manufacturing economy behind tariff walls is not a million miles from the central idea in the Labour Left's Alternative Economic Strategy of the 1980s.⁴²

In the USA domestic manufacturing is around 10% of the economy. In the UK around 9%. Both countries went down the road of globalisation in the 1980s, either allowing domestic manufacturing to relocate abroad or failing to create conditions at home for it to prosper. The Tories – Howe, Lawson and Thatcher – were entirely City of London-focused, knowing and caring nothing about manufacturing Britain. Their successors and acolytes, Brown and Blair, thought manufacturing didn't matter, that there was a natural evolution away from making things to 'the knowledge economy'.

Well, here we are. According to a report by the The National Institute of Economic and Social Research (NIESR) – to quote the subheading of their story

- 'While some enjoy a standard of living comparable to the most prosperous regions of Europe, the poorest are now poorer than the poorest parts of countries like Slovenia and Malta.'⁴³

Covid-19's origins

Every once in a while the *Daily Mail* website publishes something none of the other British major media would. On 16 March they carried the text of a 2020 report on Covid's origins, commissioned by the former head of SIS, Richard Dearlove. The report begins: 'It is now beyond reasonable doubt that COVID-19 was engineered in Wuhan Institute for Virology'.⁴⁴ It assembles the evidence that was then available – much of it on-line.⁴⁵ The only outstanding unknown is why this was suppressed in the Anglosphere.⁴⁶ Fear of offending China? Or fear of revealing US and UK involvement in biological warfare research? Both, perhaps.

Ukraine

A really interesting piece by Tim Pendry appeared in March on his new Substack site. Here are the paragraphs which struck me:

If there is a root to the current world crisis it is in allowing vengeful post-Soviet neo-nationalists to becoming the tail wagging the Western dog – a point made clear by Trump's frustration with Zelensky's emotional hatred of Russians. The European Union has a similar emotional Russian-hater heading its central foreign affairs role. . .

The problem is that Zelensky is under pressure at home. His entire political persona is based on an ability to contain the loopier neonationalist elements in Ukrainian political society who have been given to understand that the war was a crusade against Russia backed by the West as a whole. . . .

Europe has now become part of the problem rather than that solution in the eyes of the White House. Europe (led by London) has miscalculated insofar as it has allowed Zelensky the deluded belief that he can win the war without American help and, at the same time, that American help will continue because of some inherent belief in Europe's importance to the West and that Washington cares about its fate. . .

Obviously the breakdown in US-Ukrainian relations (which was eminently predictable) completely unravelled the prior European position on the war. This was to have the Ukrainians degrade the Russian economy at their own human expense but backed and financed by not only Europe but by massive US financial and military support commitments. The game was to break Russia without triggering a continental conflict in the knowledge that the US would come hurtling in with its massive resources if Russia crossed a red line. As of January 20th, this all changed. Trump recognised that the US was being manipulated and, worse, possibly into nuclear confrontation and that the Russian economy and will to fight were not breaking under the strain and were unlikely to do so. Trump is actually the most rational and informed actor here other than Putin. . . .⁴⁷

Pendry's reference to 'post-Soviet neo-nationalists' sent me back to the big piece on the role of the far right in the Maidan Square events which triggered this crisis: Ivan Katchanovski's 'The far Right in Ukraine During the Euromaidan and then war in Donbas'.⁴⁸ This essay shows that it was members of far right and neo-Nazi Ukrainian groups which did the Maidan massacre, leading to the resignation of the then pro-Russian president Yanukovych, which kicked the present crisis into gear. (Conventional accounts in the West generally attribute the Maidan deaths to Ukrainian 'security forces'.) Russia's talk of 'denazifying' Ukraine is not merely rhetoric.

At time of writing, there is not yet a Ukraine-Russia peace deal but whenever it comes, it will be similar to that almost agreed between Russia and

the Ukraine in 2022, before most of the current death and destruction had taken place.⁴⁹ President Putin talked about this failed deal in a long *tour* d'*horizon* in 2024,⁵⁰ in which he said this:

Our units were indeed deployed near Kiev, and the military departments and the security bloc had different proposals on our possible further actions, but there was no political decision to storm the city with three million people, no matter what anyone said or speculated.

In fact, it was nothing else but an operation to coerce the Ukrainian regime into peace. The troops were there in order to push the Ukrainian side to negotiations, try to find acceptable solutions and thereby end the war Kiev had started against Donbass back in 2014, and resolve issues that pose a threat to the security of Russia.

Many Western commentators have that noted the 2022 peace deal would have left Ukraine as essentially at the mercy of Russia: no NATO membership and a small army.⁵¹ But this is always going to be the outcome if the US is not going to make Ukrainian NATO membership a condition of a peace deal; and it won't.

The British Gladio

Back at the story of the British Gladio, published in *Lobster* 81. In this column below I quoted a paragraph from Wayne Thallon's *Devil Incarnate* (London: Mainstream, 2007), the memoir of Athol Visser, a British mercenary, which was quoted in another book. Visser wrote:

The [Gladio] network varied, though, in its purpose and its goals depending in which European country it was operating within. Britain's stay-behinds, for instance, were tasked to combat a specific internal threat, which was the attempted takeover of civil government by militant left-wing groups.

I got a copy of the Visser book to see if he had anything further to say on the British Gladio. There is this on the same page (p. 239):

The UK network was thus operated by Britain's intelligence services and selected members of the armed forces. In a very real sense MI5 operated a civil army with trained operatives, and infiltrated them into whichever left-wing group they saw fit.

Certain elements of the criminal world were also part of the staybehind force. These underworld members were loyal to the right-wing cause and, importantly, should senior figures see an outright *coup d'état* necessary in the event of a militant Labour win at election, they were well outside of government control.

Which is what Peter Sanderson described in *Lobster* 81.

In that piece, I quoted a section of a much longer piece about the origins of the stay-behind network in the Reserve Forces Association. Here is the whole thing.

UNDERCOVER RESERVE FORCES

A paramilitary committee of former high-ranking service officers has, for the past six years, been receiving official government support to set up an undercover, anti-communist resistance movement in Britain (*Daily Express* 18/7/77). The Resistance and Psychological Operations Committee (RPOC) is a covert group within the government-funded Reserve Forces Association (RFA). The RFA is the representative body of British military reservists, and the British component of the NATOsupported Confederation Inter-Allies des Officers de Reserve (CIOR). The RFA-was formed in 1970 and is formally an independent organisation, but its 214 individual and 90 corporate members represent all the reserve units of the armed forces and the government treats it as the spokesman of Britain's reserve forces.

Since 1971 the RPOC has been setting up the nucleus of an underground resistance organisation which could rapidly be expanded in the event of a Russian occupation of any part of NATO, including Britain. Close links have been formed with similar units in several European countries, which are actively recruiting 'anti-communist resistance fighters', according to Chapman Pincher. They are also said to have established an intelligence network which NATO chiefs regard as being of great value.

The RPOC was set up by a group of World War Two defence chiefs who thought that the need has arisen again for an organisation like the underground wartime Special Operations Executive (SOE), but this time directed against communism. Amongst the group were: General Sir Richard Gale, former NATO Deputy Supreme Allied Commander, Europe, and founder of the 1st Parachute Brigade; Sir Colin Gubbins, founder of the SOE and the Commandos; Sir John Slessor; Marshal of the Royal Air Force, and former Chief of the Air Staff; and Sir Algernon Willis, Admiral of the Fleet.

Under the then Tory government RPOC was given access to Ministry of Defence Departments, including the Joint Warfare Establishment near Salisbury commanded by Maj. Gen. Patrick Ovens, a former Commando. The committee also formed close links with the Special Air Services (SAS), and secured access to the Foreign Office's Information and Research Department, which has historically been used as a cover Department for M16 agents. The MOD gave the RFA a grant to pass on to RPOC. Now, Pincher claims, the Labour government are worried that their supporters will find out that the government has been encouraging a rightwing paramilitary group, and they have therefore been quietly trying to stifle the committee over the past months. RPOC has been deprived of its grant (and thereby its official status), access to Whitehall information has ended, and attendance at NATO meetings forbidden. The committee still exists, however, with General Gale leading the fight for its survival.⁵²

Assuming Pincher's account is accurate – and he is clearly repeating what he was told by someone involved with RPOC – while RPOC may have lost its funds from the Ministry of Defence, the Reserve Forces Association did not. Peter Sanderson and others in the Territorial Army were recruited and tasked initially to locate and clear the old arms and equipment dumps left from the 1950s stay-behind network, before creating up-to-date dumps in new locations. So, evidently, the creation of a new stay-behind network had been approved in Whitehall at some level (though probably well out of sight of the politicians because, like the spooks, the MoD is almost entirely free of political supervision). As Sanderson describes it, this stay-behind network was then repurposed to act as a clandestine anti-labour (and, if necessary, anti-Labour) network – exactly as Visser wrote.

At the back of all this were the fantasies on the British right about the communist threat to Britain. In a recent essay Richard Norton-Taylor has written:

A senior Home Office civil servant reported that Thatcher was 'convinced that a secret communist cell around Scargill was

orchestrating the [miners'] strike in order to bring down the country'.53

Which raises the interesting question of what MI5 told Mrs Thatcher. For they had the Communist Party of Great Britain completely penetrated – as well as agents and sources within the NUM – and knew there was no 'secret communist cell' around Scargill. Did MI5 tell her the truth? If they did – and this is not a given – did she chose to ignore MI5's briefings and believe those, such as Brian Crozier and David Hart, who had been telling her about 'the threat from the left'?⁵⁴ She would not be unique in being unable or unwilling to give up one of her central beliefs, despite evidence which falsified it.

Briefly

There is a recent piece in the *Irish News* in which one Paul Cleeland claims to have been framed for murder after acting as an MI5 assassin in Ireland.⁵⁵ Being framed by the British state rings a bell. Patrick Meehan claimed MI5 framed him for murder because he knew something potentially embarrassing about the British state 'springing' Soviet spy George Blake from prison;⁵⁶ Colin Wallace was framed for manslaughter because he knew about MI5's anti-Labour psy-ops in 1974; and Peter Sanderson was framed for robbery to discredit anything he chose to say about the British Gladio.

Trump's links to Russia, and Russian attempts to promote him in the US, is a big subject which divides the American left and the right. Within that is a sub-theme, that Trump is actually a Russian agent. A summary of the evidence supporting this view – and there's rather a lot of it – has been published by

There is an interesting essay by Simon Willmets on the impact, both domestically and internationally, of the book by David Wise and Thomas Ross, *The Invisible Government* (London: Random House, 1964), the first book in English about the CIA, which kicked much of this off.⁵⁸ One curiosity: he writes:

Another inspiration for Stone's film was another well-known popularizer of the 'invisible government' or 'deep state' JFK conspiracy theory: Leroy Fletcher Prouty.

But he omits the fact the Prouty had been a Colonel in the USAF and liaison with the CIA and knew first-hand whereof he spoke.⁵⁹

File under 'All our yesterdays'.

Labour's problem

Looking through old issues, I noticed that in my column in number 64 I had reproduced Simon Lee's summary of his 2012 paper 'Gordon Brown and the British Way of Risk-Based Modernization'.⁶⁰ In that was this.

This paper argues Gordon Brown's analysis is fundamentally flawed. We are not now living through the first crisis of globalisation. On the contrary, what Gordon Brown has actually documented is the first crisis of his own deeply flawed British model of political economy, which socialised risks and privatised profits. The paper explores how Gordon Brown's attempts to modernize the politics and political economy of the United Kingdom, using the City of London's liberalized markets as a blueprint, has left the United Kingdom facing an age of austerity that was politically self-inflicted rather than financially imposed by external global market forces.

'[S]ocialised risks and privatised profits' – exemplified by the Private Finance Initiative (PFI) which 'borrowed' large amounts of private capital in a manner

which excluded the borrowing from the public spending figures. This was presented to us as a clever wheeze at the time but it looked like an expensive way to borrow money; and so it has proved. A recent report from the National Institute for Economic and Social Research, 'PFI: Getting the Bill on the Fiscal Credit Card',⁶¹ showed that with this kind of finance 'repayment costs [are] 3.3 times larger on average than the value of the infrastructure they built'. The study also noted in the PFI funding of schools,

Eight companies own 80 per cent of all PFI schools projects;

£1 billion has been made by PFI companies in pre-tax profits from all contracts: £300 million has been distributed as dividends;

Of these eight companies, five are registered offshore.

Altogether now: thanks Gordon!

Asil Nadir: the cover-up continues

Asil Nadir's death hit the media on 11 February. None of the obituaries which I have read strayed beyond the conventional line.⁶² *The Times* had a full page obituary and another full page on him of the I-was-there feature variety. None of the accounts mentioned the awkward fact that a record 36 Public Interest Immunity certificates were issued during Nadir's trial to prevent material being discussed in court. These events demonstrated – if demonstration was needed – (a) that the British major ('legacy') media can still be trusted by the state to toe the line when requested to do so; and (b) there are few limits to what the British state will do to avoid embarrassing its 'ally', the United States.

The website of the Justice for Asil Nadir Committee (JANCOM) is no longer on-line but a section of it is still available on web.archive⁶³ and other important parts of it are to be found on Wikispooks.⁶⁴ Most important of all are the two essays on these events which appeared in *Lobster* 66: JANCOM co-founder Martin Tancock's 'Secret Justice: Public Interest Immunity Certificates (PIICs)

Extraterrestrial psy-ops?

More from Dick Russell. On his Substack, on the subject of UFOs, he quotes Steven Greer, front man of the Disclosure Project for twenty years.

There has been a deliberate comingling of information with disinformation, including amateur researchers who rubber-stamp abductions, [animal] mutilations and other things that we can prove have been and are covert psy-ops, all human. Yes, people have had contact with extraterrestrials, *and* people have been abducted by *extraterrestrial look-alike objects*. The long-term agenda of a transnational criminal organization, which involves aerospace companies and some compartmented government operations in various agencies, is to present an external threat from outer space to unite the world around a militaristic totalitarian system.⁶⁷ (Emphases in the original.)

Strewth . . .

Most parapolitical research has been done by the left. But a group on the right, calling itself Marco Polo, has done an enormous piece of research on the notorious Hunter Biden lap-top.⁶⁸ And 'enormous' here means over 600 pages, over 2000 footnotes and hundreds of screenshots of internet activity. It is mind-boggling but virtually impenetrable to me. I simply don't know enough about the Washington political scene to understand let alone evaluate the influence peddling depicted in the laptop. Below is a page picked at random to show the style: text, footnotes, screenshots. There is a fair bit about Biden's love of drugs and hookers.



Which is what Peter Sanderson was describing in the piece I wrote in *Lobster* 81, 'The British Gladio and the murder of Sergeant Speed'.⁶⁹

All Musked up

 \mathbf{T} his is Carole Cadwalladr, in her first post on her new Substack, on the threat posed by Elon Musk:

'[Elon] Musk owns the information equivalent of an entire fleet of aircraft carriers and fighter jets. And last week he demonstrated his almost total command and control of the UK information space.'⁷⁰

But the UK government could simply prevent any of his nonsensical outpourings from arriving here. As I pointed below under subhead **And yet . .**, Brazil turned X off for a month. Let us not exaggerate the power of the people running social media. They exist courtesy of our states. Of course, the present government doesn't have the bottle to do it, but still. . . .

'Intelligence' you call it?

On *Quora* there are interesting posts by one Thierry Etienne Joseph Rotty, who describes himself as having been a member of Central Planning at NATO.⁷¹ Thus far no-one has been able to stand that claim that up. This post of his caught my eye. Asked 'What surprises did American intelligence learn after the fall of the Soviet Union when Russia shared KGB information with the US?', he replied:

There were several:

- The most shocking was the existence of Biopreparat, the agency running the enormous clandestine biological weapons program. The US had no clue this even existed.
- 2. The existence of two secret Main KGB Directorates: the 10th and the 14th. The job of the 10th was to protect Biopreparat and the

14th had to spy and check up on the 12th Main Directorate of the Ministry of Defence which was in charge of guarding nuclear weapons. "Who guards the guards?" ... well, the 14th did.

- 3. When the KGB gave a copy of the East German Stasi files to the CIA (just to stick it to the Germans one last time), it turned out that at any time, the Communist Bloc had some 200,000 spies in Western countries.
- 4. These files showed that the USAF had been hopelessly infiltrated by communists in the 1950s and 1960s. The US already knew this, but not the massive scale.
- 5. The old joke that NATO defence information ended up in the Kremlin before it filtered down to the various NATO countries turned out to be true. Only nuclear planning had not been infiltrated.
- 6. The US had not been able to keep anything a secret from the Warsaw Pact. It turned out they knew exactly what kind of weapons the US was developing and what the military capabilities were. It was clear counterintelligence had been a huge failure (the same applies to the other NATO countries as well).
- 7. The Soviets did not plan on hitting most US cities with nuclear weapons, something military planners had suspected. Instead, they would have gone for the major conventional army and national guard bases. The idea was that food shortages and race riots might destabilize the US government. Since invading was never an option, internal strife was the only hope of bringing down the US government. Agitators would have been instrumental in trying to achieve this.
- 8. There had been a KGB plan to kill Pope John Paul II. It was abandoned as the Soviet Leadership feared a PR disaster and worldwide reprisals.⁷²

If items 3, 4, 5 and 6 are true, they reduce much of the US (and NATO) intelligence effort since WW2 to little more than an expensive farce. However, *if true* . . . What about the claim in item 3 that there were 200,000 Soviet bloc

spies in the West?⁷³ I can't find a gross total but there is this about the East German secret police, the Stasi.

One consists of the so-called Rosenholz (Rosewood) records. Two card indexes of people who were subjects of the HVA's [HVA = Main Department for Reconnaissance] interest in 1988 were microfilmed. These F16 and F22 indexes include, among other people, the service's agents. As the GDR was collapsing, the U.S. Central Intelligence Agency obtained a copy of the indexes, which it made available in 1993 to the BfV. The indexes state the real name and codename of each spy. In the 1990s, they enabled the foreign intelligence network of the HVA and the Stasi's security departments to be uncovered. They enabled the size of the HVA's agent network to be established: between the early 1950s and the late 1980s the service ran approximately 6,000 spies in West Germany. The Stasi's security departments ran a similar number of spies in the Federal Republic in the same period. These 12,000 agents were supported by a network of approximately 40,000 East German couriers, instructors, and intermediaries. The ministry's foreign intelligence network consisted of approximately 52,000 people in all.⁷⁴

In total that gives the East Germans 18,000 agents over the period of the 1950s to late 1980s in Germany. At any one time, who knows how many were active? Even so, did the other members of the Soviet bloc and the Soviet Union itself really have another 180,00 agents?

Like a bat out of . . . Wuhan?

There was a striking piece in the *Daily Telegraph* by Matt Ridley, 'The explosive truth about the origin of COVID-19 may finally be about to emerge'.⁷⁵ Alas, this is behind a pay wall. However, Ridley has a blog and you can read similar

material there.⁷⁶ He shows how Chinese money – in this country, e.g., into British universities and publishing – has prevented an honest assessment of the evidence about the origins of the COVID outbreak in Wuhan.

I nibbled at the story in this column (put 'Wuhan' into the search facility on *Lobster*'s site) but seem to have got the major threads correct: viz. that the Wuhan lab story was initially being suppressed in the Anglosphere because of the American money apparently funding Chinese biological warfare research. Not that it was difficult to follow if you had no vested interest in the story. It was only people with careers, income and status at stake who were inclined to ignore the data.

The day I wrote the lines above, the new (Trump-appointed) Director of the CIA announced that the Agency believed it was probably a lab leak – a major move from its previous sitting-on-the-fence position. Evidently the new Trump administration is not nervous about antagonising China.

Back at the COVID outbreak . . . on the principle of never letting a crisis go to waste:

At the height of the COVID-19 pandemic, the U.S. military launched a secret campaign to counter what it perceived as China's growing influence in the Philippines, a nation hit especially hard by the deadly virus.

The clandestine operation has not been previously reported. It aimed to sow doubt about the safety and efficacy of vaccines and other lifesaving aid that was being supplied by China, a Reuters investigation found. Through phony internet accounts meant to impersonate Filipinos, the military's propaganda efforts morphed into an anti-vax campaign. Social media posts decried the quality of face masks, test kits and the first vaccine that would become available in the Philippines – China's Sinovac inoculation.⁷⁷

This resulted in a very low take-up of the vaccine in the Philippines and thousands of unnecessary deaths.

Labour Together

The group which funded Keir Starmer's run at the leadership of the Labour

Party, Labour Together, was discussed in *Lobster* 88.⁷⁸ The essential *Open Democracy* reported recently:

... it is still pulling in major sums from the party's big donors. Labour Together has received more than £850,000 since the election – including more than £320,000 each from hedge fund boss Martin Taylor and Lord David Sainsbury, plus £200,000 from Gary Lubner, the boss of Belron, a firm specialising in vehicle glass repair.⁷⁹

IRD

Rory Cormac is one of the British academics working on the Information Research Department (IRD), now that some of its official files are open to inspection.⁸⁰ Cormac recently wrote an essay with the provocative title 'In defence of the Information Research Department'.⁸¹ He writes:

At its peak in the mid-1960s, it [IRD] had a staff of 390 and operated as a semi-secret entity with a straightforward goal: to counter hostile narratives by raising awareness of conditions behind the Iron Curtain and by exposing competitors' activities particularly in what is now commonly referred to as the 'global south'.

Professor Cormac has read the declassified documents and I haven't; but even from the fragments we knew before declassification, this description is generous and falsified by Cormac's own research cited in note 52. I would put it like this: IRD's aim was to keep the left down at home and prevent the rise of nationalism in the British colonies and former colonies. When it came to its last big operation in Northern Ireland in the 1970s, it went as far as smearing Labour MPs who were perceived as sympathetic to Irish nationalism.

Dallas again

Meanwhile, back at the LBJ-dunit branch of the JFK assassination research, mid January saw what may prove to be a major step forward. At the centre of the LBJ-dunit thread is the late Billie Sol Estes, a Texas businessman-cum-con artist who was defrauding the US government of tens of millions of dollars a year through bogus agricultural subsidies; and feeding some of that back to then Vice President Johnson.⁸² When the Johnson-Estes link was threatened with revelation, witnesses to the fraud in Texas began dying. Estes later claimed that he had made tape recordings of his conversations with various people involved and that it was the threat of these recordings being released which was keeping him alive.

In chapter 27 of his memoir, Estes reported a conversation in 1971 with LBJ's no. 1 assistant, Cliff Carter, in which they discussed the JFK assassination and the role in it of LBJ, Carter and their gopher-cum-hitman Malcolm 'Mac' Wallace.⁸³ What is allegedly part of the tape recording of that conversation has been made public by Estes' grandson.⁸⁴ We can apparently hear Carter talking to Estes about Wallace and the assassination.

The putative witness to that meeting of Carter and Estes, one Kyle Brown, unnamed by Estes in his memoir, had previously confirmed the conversation's existence and some of its content.⁸⁵

All together now . . .

In this column in *Lobster* 87, *apropos* the then developing economic crisis, I wrote:

The traditional British response to a crisis – and this is a really big crisis

- is to abandon party politics and form coalition governments to do unpopular things. The interesting questions now are how long it will take before the crisis is acknowledged? And who will be first to suggest a coalition?

The first small step in the national government direction was taken when Health and Social Secretary Wes Streeting said, after announcing another inquiry into social care:

We will have cross-party talks next month. And I'm really encouraged by the fact that since the election, the Conservatives, the Liberal Democrats and Reform have all said that they want to work acrossparty on this, and those talks will begin next month.⁸⁶

It makes obvious political sense to have unpopular decisions taken by a crossparty consensus: the government may avoid carrying some of the blame. And if a party declines to take part, or blocks the creation of a consensus position, they can be attacked for being obstructive etc.

Next target for cross-party talks? My guess would be pensions, the socalled triple lock. Within the economic framework apparently accepted by this government (and the opposition parties), the triple lock is not affordable.⁸⁷

Briefly

David Aaronovitch has a Substack called *Notes from the Underground*. He is self-described there as 'Writer, broadcaster, author, editor, producer and former *Times* columnist for 18 years'. Very underground!

With CIA, Mossad'.90 Big stuff.

Dick Russell you may know from his JFK research.⁹¹ He has a new Substack site on which there is a very odd – *very* odd – story about Chinese and US drones using 'gravitic propulsion systems'.⁹² Reading that I was reminded of the first law of conspiracy: if you can imagine it, it's been tried already.⁹³

Pennies dropping

Very striking piece in *The Observer* on 29th December by Will Hutton, 'Britain will never be great again until we stop flogging our top companies to the US'.⁹⁴ This column is essentially a paraphrase of – and a great plug for – Angus Hanton's *Vassal State: How America Runs Britain*.⁹⁵ All well and good Will, and I am happy to see you've still got the odd radical impulse left in you. But can you see Starmer's Labour signing up for anything even vaguely resembling this? Their big idea seems to be rather than taxing the wealthy, they will sell off more of the UK to global asset management companies like Black Rock.⁹⁶

Daniel Finkelstein on RFK's assassination

It was inevitable that a member of our political commentariat would move

from Robert Kennedy Jnr's – let's be generous – *eccentric* views on vaccination to his belief that his father was killed in 1968 by a conspiracy. In the event it turned out be Daniel Finkelstein – Baron Finkelstein – associate editor of *The Times* and columnist for that paper. Finkelstein devoted the first part of his piece in *The Times* on 10 December to RFK Jnr, Sirhan Sirhan and the RFK assassination. This was his opening sentence.

Sirhan Sirhan was standing right by Robert Kennedy on June 5, 1968, when he shot and killed the senator with a .22 revolver. The whole thing could have hardly been more clear-cut.

Finkelstein has got the basics wrong: in fact Sirhan Sirhan wasn't 'standing right by Robert Kennedy'. He lunged towards RFK firing his pistol. A little more reading – say of the memoir of the man who did RFK's autopsy⁹⁷ – would show that RFK was killed by a contact wound to the base of the skull and that the bullets in RFK didn't match Sirhan's gun.⁹⁸ The actual shooter must have been the late Thane Cesar, a temporary security guard who was standing behind RFK.⁹⁹ It was Cesar's clip-on tie which RFK pulled off before he collapsed.

Finkelstein knows nothing about the event and here's the striking thing: he doesn't feel a need to know anything about it before offering his opinion. There is something about the designation 'conspiracy theory' which obviates the normal requirement that you know whereof you speak.

Faking it

I have been working my way though the back copies of *Lobster*, checking for lay-out errors which happened when the first 56 issues were digitalised in a hurry by me, Jane Affleck and Ian Tresman. In the process I have been reminded of the content of said back issues, much of which I had forgotten about.

One of the things that struck me is the way *Lobster* – and many others, of course – documented an endless series of economic and social disasters as the free market, neocon view of the universe was implemented here. And yet our political system – our state – carried on regardless.

With the free market nonsense came a belief that if the public sector couldn't be abolished, it needed a kick up the backside and its expenditure reduced. Target-setting was imposed throughout by management. When this didn't produce the results it was supposed to, rather than admit it didn't work – the rational move – the political system preferred that the public sector fake results showing success. In *Lobsters* 43 and 44 I discussed such faking in public financing, long-term sickness, the numbers rough sleeping, schools, Oxbridge research, medical stats, school league tables, poverty, hospital waiting lists, street crime, ambulance response times, doctors' working hours, unemployment figures and welfare fraud figures. I'm sure you know of other examples.

So why could the political system – the politicians – not admit that the neocon ideas had failed? I think there are two parts to the answer. The first is the general point that many – perhaps most – people are reluctant or unable to change their minds. The older we get the more difficult we find change; and, the more important those ideas are to us, the harder we find it. The second point is the particular difficulty perceived by politicians in admitting mistakes. After all, they present themselves as leaders and, they seem to believe, they lose credibility if they acknowledge mistakes. In the case of the current Labour Party, having abandoned most of what it believed in adopting Thatcherism (in all but name), how can it now say 'Everything since 1979 has been a mistake?'

And yet . . .

We are told every day that the social media companies of Mr Musk and his ilk are enormously powerful. And yet Albania – population two and a half million – has recently announced it will shut off TikTok to Albanian citizens for a year because of fear about the app's effects on children.¹⁰⁰ In September 2024 Brazil cut off the X app to Brazilian citizens and, faced with this, X paid an admittedly small fine of \$5 million dollars to have it switched back on.¹⁰¹

So who has the power? Apps or states?

The Sun reveals . . .

I don't often quote The Sun newspaper but it published a very good analysis

.... More than two dozen ministers including Rachel Reeves, Pat McFadden and Wes Streeting all have spouses or relatives on the taxpayer or Labour Party payroll, analysis shows.¹⁰²

Definitely worth a look.

The Skripal inquiry

Or, more accurately, the inquiry into the death of Dawn Sturgess, who died after absorbing novichok in Salisbury. Some of the inquiry's proceedings are available. As you would expect, most of it is of little interest but there was this oddity. On the left is part of the text of a restriction order in which there is a redaction. What who – do you suppose was redacted?

The Economic League

In *Lobster* 28 I reviewed Mike Hughes' *Spies at Work*, in which he pulled together the fragments of information then available about the Economic League. Thirty years later Hughes has had another crack at it. In the intervening years, largely thanks to campaigners like Hughes, a great deal of information about the League has become available. In his new *Inside The League*, Hughes has written a detailed history of the organisation, its activities, its personnel and its decline and fall.¹⁰³

Dallas again

Two pieces have recently appeared about D. H. Byrd, the Texas oilman, friend and supporter of Lyndon Johnson. Byrd owned the Texas School Depository Building from which Lee – 'I'm just a patsy' – Oswald is supposed to have fired on JFK's motorcade. The first essay, by Russ Baker,¹⁰⁴ points out that Byrd established an elaborate alibi for himself, big game hunting in Africa, when the assassination took place. This alibi is duly unpicked by Baker.

Byrd is also the central subject of the second essay, by *CovertAction Magazine*'s editor Jeremy Kuzmarov. This shows, as the title has it, `LBJ Insiders D.H. Byrd and James Ling Bought 132,000 Shares of Stock in Defense Contractor LTV in November 1963 Around Time of the JFK Assassination'.¹⁰⁵ This is significant because, shortly after Johnson became president, LTV was awarded a contract to build military planes and the LTV shares, which Byrd had bought at around \$16 each, rose to \$169. This share deal may suggest that Byrd knew about the assassination plot in advance.

And others in Dallas were apparently in the know. In the 1995 *The Men* on the Sixth Floor, Glen Sample writes on p. 178:

During the research and investigation phase of this book I had the opportunity to communicate with a retired member of the intelligence community, who told me about an event he once attended, a luncheon at the Petroleum Club in San Antonio, in 1973.

'I couldn't pass up the chance to ask Texas oil guys their view of

the Hunt family being involved in JFK's death. After much laughter my host said, "Hell, half of Dallas was in on it!" ¹⁰⁶

*

In his essay Russ Baker (see above) also writes this:

As for the TSBD [Texas School Depository Building] company itself, several former employees have described to me and others company activities, including the apparent covert shipment of things other than books in book cartons, that made clear to them the outfit had its own connections with the intelligence world. In addition, Elize Glaze, a reporter for the *Austin American-Statesman*, researched and interviewed Bill Shelley, Oswald's supervisor, and later noted, "Mr. Shelley claims to have been an intelligence officer during World War II and thereafter joined the CIA."¹⁰⁷

If it is true that the TSBD was the cover for military/intelligence operations – and the evidence presented by Weston in note 79 is suggestive rather than conclusive – it would explain why Oswald, *qua* intelligence operative, took the badly paid job there: it was another part of his cover story. And as he was apparently steered towards the job by Ruth Paine, it is another hint that Paine, as many suspect, was herself CIA.¹⁰⁸

I was looking through posts on John Simkin's JFK Assassination Debate¹⁰⁹ and noticed some discussion of Joachim Joesten and decided that since I think LBJdunit (or was one of those who done it), I'd better read Joesten's *The Dark Side of Lyndon Baines Johnson*, even though it is over fifty years old. It is apparently available free on-line¹¹⁰ but I was unable to open the file there and bought a copy at abebooks. The version I got is a 2013 reprint and I simply cannot tell if this is the same as the original edition. I presume it is. It has no index and no notes, though there is some documentation within the text when he quotes newspaper articles. Considering he wrote it in 1965/6, it is a very

striking run through all the then available information about LBJ and his corruption – Billy Sol Estes, Bobby Baker etc – and what little was then known about the murders surrounding the Estes events.

There are three items which suggest that Joesten was being run by the KGB. Joesten had been a member of the German Communist Party before the war and had his first book on the assassination published by a small New York outfit, Marzani and Munsell, subsidised by the KGB.¹¹¹ The second is the report on the JFK Assassination Debate site by Brigette Wilke that a 1958 Joesten book in German, titled *CIA*, described the National Security Agency (NSA)'s work in some detail and even named its then director, Ralph Canine.¹¹² As the existence of the NSA was not publicly acknowledged until the 1970s, this came from an intelligence source, presumably the KGB. The third is the fact that Joesten's writing about the assassination echoed the KGB's view of the event. When the KGB thought it was probably the CIA and/or the oil millionaires behind it, Joesten's book said the same. When the KGB acquired information in 1965 that LBJ was behind it, Joesten switched to writing his LBJ book.¹¹³

Twixt lip and cup (or something)

A classic of the headline–and–text–differing genre was on the *Daily Mail* site of 2 December. In 32 point the headline proclaimed:

The secrets of Vladimir Putin's riches and the Salisbury poisoning: Russian president ordered hit on Sergei Skripal 'because he feared he would expose how he stole his vast fortune'.¹¹⁴

The opening sentence of the text begins:

Vladimir Putin *may have* ordered the bungled (Emphasis added.)

Kincora

Steve Dorril wrote about Kincora in the first issue of *Lobster*. We continued to cover the subject through many subsequent issues, especially after we made contact with Colin Wallace. Because the scandal has never been properly examined officially, the story keeps cropping-up. The latest instalment is a kind of memoir by Roy Garland, a member of William McGrath's Tara organisation, who blew the whistle on McGrath in 1973 to the RUC but was ignored. The first part is 'Roy Garland on corruption in high places'¹¹⁵ and the second is 'Tara and Kincora, the RUC link'.¹¹⁶

UAPs, UFOs – whatever

A very striking, massively detailed article by former State Department analyst Marik von Rennenkampff on the subject of the US state's knowledge of UFOs has appeared on *The Hill*.¹¹⁷ The 50 links in the text go to recent admissions – official and unofficial – by US military and intelligence sources on the subject. Taken individually, some of the recent statements are striking. Pulled together, as they are in this essay, the effect is overwhelming. Essentially the US military and intelligence services know – and have known for some time – that the earth, and its military installations and equipment in particular, are being regularly visited by vehicles from . . . somewhere else . . . vehicles whose performance the Pentagon can't understand, let alone replicate.

Changing times . . .

In one of his (now deleted) YouTube pieces Professor Jeffrey Sachs mentioned a book about US covert action: Lindsey A. O'Rourke, *Covert Regime Change: America's Secret Cold War* (Ithaca: Cornell University Press, 2018). (Be warned: there are apparently free PDF copies of this available on-line, but my computer's system flagged the sites I checked as potential sources of malware and/or viruses.) There have been many positive reviews and this, from a

review by David S. Foglesong in the *Journal of American History*, sums it up quite nicely.

Drawing on a wide reading in secondary sources supplemented by research at the National Archives and presidential libraries, O'Rourke analyzes sixty-four covert interventions from 1947 to 1989. After examining the causes, conduct, and consequences of the covert actions in chapters 3–5, O'Rourke turns to case studies of U.S. actions in Eastern Europe, Vietnam, and the Dominican Republic. She finds that more than 60 percent (39 of 64) of the efforts failed and most did not remain secret; yet policy makers continued to resort to covert actions and to overestimate their ability to keep the U.S. role hidden.¹¹⁸

Not only is an American academic writing this, she is getting good reviews and lots of attention. This is another example of the climate changing. Would she have found an academic publisher willing to handle it twenty years ago?

I noted in the previous *Lobster* that *Foreign Affairs*, house journal of the Council on Foreign Relations, had recently published this:

For decades, American presidents have waged illegal wars, plotted to assassinate foreign leaders, unlawfully detained and tortured people, toppled democratic governments, and supported repressive regimes without any possibility of legal accountability in either domestic or international courts.¹¹⁹

Foreign Affairs also published Paul Krugman's review of Henry Farrell and Abraham Newman's *Underground Empire: How America Weaponized the World Economy.*^{' 120} While he's no Marxist, Krugman is what passes for a radical economist in corporate America and here he is in one of their house journals.

The Israel lobby

According to *Lobster*'s search engine, AIPAC, the American Israel Public Affairs Committee, was first mentioned more than 20 years ago in issue 49 by Tom Easton, and has been referred to fairly regularly since. Its activities are now a feature on several leftish sites. The best recent essay I have seen is by Branko

Marcetic at *In These Times*.¹²¹ It documents current AIPAC activity against Democratic Party politicians who are less than enthusiastic supporters of Israel. The equivalent UK site is the UK subsection of Track AIPAC.¹²²

Dropsitenews is carrying a very striking account by an American journalist of an Israeli-funded press junket to Israel. Of course the American hacks got a ton of anti-Hamas and anti-Muslim propaganda. That was the point of the exercise. What is striking is the absurdity and crudity of the material offered by the Israelis. Evidently the Israelis involved think American hacks are stupid and gullible.¹²³

Politicians and economics

Few politicians bother to learn elementary economics and the monetarist idea of the mid 1970s – control the money supply and you can control inflation – appealed because it was so simple. It took hold, particularly in the Conservative Party, where what became the Thatcherites adopted it and wrecked the British manufacturing economy with it between 1980 and 1984.

Margaret Thatcher was a politician who knew no economics. John Hoskyns, a businessman recruited to join the Thatcher team as Head of the Policy Unit, records in his memoir:

I had been concerned since before the election [of 1979] that the pound was too high. Margaret [Thatcher] seemed to be convinced that `the higher the pound, the better for the economy'.¹²⁴

(As a high value pound makes imports cheaper and exports more expensive, it is bad for the domestic manufacturing economy.)

This brief trip down memory lane was prompted by a very good essay in the *New Statesman* by Florence Sutcliffe-Braithwaite, 'The Thatcher delusion'.¹²⁵ Alas, we don't live in a world in which the leader of the Labour Party will stand up and say that the free market moves since 1979 have all

been a mistake. Even if Mr Starmer thought it, this would entail criticising Mrs Thatcher's acolytes, Tony Blair and Gordon Brown, and he won't do that.

To judge by Chancellor Reeves' Mansion House speech in November, she isn't going to entertain any deviant ideas.¹²⁶ It was all pretty standard stuff and might have been delivered any time in the last 45 years. The financial services sector, she told her audience, is:

... the crown jewel in our economy. It employs $1 \cdot 2m$ people, from London to Edinburgh, and from Manchester to Belfast. It is one of the country's largest and most productive sectors, accounting for 9% of our economic output.

Of that 9% about half is in London – that's 'the City', the real 'crown jewel'. The rest is retail banking and insurance spread throughout the UK. So this 'crown jewel' is about 4.5% of economic output. At 9.1% of economic output, and thus twice the size of 'the City', is manufacturing.¹²⁷ But the word 'manufacturing' is not in Reeves' speech. What *was* in her speech was a promise to reduce the regulation of the City, imposed after the last financial crash. What could possibly go wrong? The excellent Richard Murphy made some similar comments.¹²⁸

Trouble at NED

The Grayzone is much too sympathetic towards Russia for me but it produces some interesting material. An example is a long account – based on leaked emails – of recent events at the US government's National Endowment for Democracy (NED).¹²⁹ NED is evidently having difficulty dealing with the contemporary world. Part of this flap is the result of the arrival of younger personnel, who are apparently as concerned with the Diversity, Equity, and Inclusion (DEI) agenda as they are with promoting democracy and US interests.¹³⁰

Among the leaked emails is one from senior NED staffer Michael Allen which includes this paragraph:

During the NED's first compulsory DEI training (conducted by an external provider) I asked why social class was not being considered alongside ethnicity, gender, sexual orientation etc.; questioned the term "micro aggression"; and observed that social justice movements have historically sought equality of opportunity, not equality of outcomes. I raised other questions at a DEI training on the 1619 Project, not least that it was an ideological, not historical project. After each session (and a couple more) certain colleagues – including my line manager – suggested that such interventions were "not helpful" and, in essence, reflected my white male privilege.¹³¹

And if you were wondering how far into the US state DEI has penetrated, you can read the CIA's version in their publication 2020–2023 CIA DIVERSITY AND INCLUSION STRATEGY.¹³²

Havana Syndrome

Anomalous Health Incidents (AHIs), discussed in this column in the previous *Lobster,* is the official US euphemism for a wide range of symptoms up to and including brain damage, referred to by all but intelligence bureaucrats as Havana Syndrome, since the first incidents happened at the US embassy there. Re-reading some of the reporting and comment on this, two things struck me. The first was the quite extraordinary lengths to which the agencies of the US state have been willing to go to publicly deny the reality of what is staring them in the face. More than 1500 US state employees connected to its foreign policy organisations¹³³ have been assaulted by *something* invisible. And this began almost 10 years ago. Yet this is the official US position as of 2023.

Since US officials first reported AHIs in Havana, Cuba in late 2016, the IC [Intelligence Community] has sought to understand whether these events can be attributed to a foreign actor and a deliberate external mechanism. The IC pursued three separate lines of inquiry: the first

encompassed work determining whether available data points to the involvement of a foreign adversary in the incidents; the second focused on the feasibility and existence of deliberate mechanisms that an adversary might use against US personnel to cause AHIs; and the third evaluated whether medical analysis can help determine if an outside actor is involved in the broad range of phenomena and symptoms associated with AHIs. **Based on the results of these three lines of inquiry, most IC agencies have concluded that it is "very unlikely" a foreign adversary is responsible for the reported AHIs. IC agencies have varying confidence levels, with two agencies at moderate-to-high confidence while three are at moderate confidence. Two agencies judge it is "unlikely" an adversary was responsible for AHIs and they do so with low confidence based on collection gaps and their review of the same evidence.**¹³⁴ (Emphasis in the original.)

When a lawyer for one of the victims made the obvious point that the CIA was covering things up, a CIA spokesperson wrote:

The Intelligence Community Assessment on anomalous health incidents released by ODNI [Office of the Director of National Intelligence] reflects years of rigorous, painstaking collection, investigative work, and analysis by IC agencies, including CIA. We applied the Agency's very best operational, analytic, and technical tradecraft to what *is one of the largest and most intensive investigations in the Agency's history*. The CIA remains committed to ensuring continued access to care for affected officers and to fully investigating any reports of health incidents. (Emphasis added.)¹³⁵

And yet they still managed to disregard the experience of over a thousand US federal employees.

The second striking feature of the reporting is the complete absence of any back story. You will not learn that the US military itself has a long history with this technology. In the 1980s the so-called peace camps at Greenham Common in the UK and Seneca in New York State were subjected to what was then called 'zapping' – electromagnetic radiation – producing effects similar to

those reported by the current victims of Havana Syndrome.¹³⁶ But then most of the research and writing on the subject was done before the Internet and there's only a few of us who can pull old cuttings from our filing cabinets.

My guess is that the US state is publicly denying the reality of Havana Syndrome because, while the US is happy to fight Russia to the last dead Ukrainian, its politicians are afraid and/or unwilling to confront the reality of Russia's hybrid warfare against them and their allies. As to why they are afraid/unwilling, I have no idea.¹³⁷

Streeting ahead

In *The Observer* on 17 November Phillip Inman had an article with the headline 'Streeting's reforms could save the NHS from the private sector. He must not fail'.¹³⁸ Inman omitted – or is unaware of – the fact that Health and Social Care Secretary Wes Streeting has taken £175,000 from private healthcare companies¹³⁹ and thus is highly unlikely to save the NHS from the private healthcare sector.
